# **Could your church use** a giving programme?

A giving programme is being offered nationally which is particularly designed for smaller, rural/village churches.

In these churches a greater percentage of the community are likely to be committed to the church than in other contexts.

The programme encourages the church to consider whether it should approach the wider community and also whether to hold a presentation event to communicate the financial needs of the parish.

Other churches may also find this useful, although without a clearly defined and supportive community they are likely to find trying to approach the wider community for support less successful. Resources include:

# Give a card this Christmas

A recent survey produced some interesting (but not unexpected) information.

Sales of greeting cards of all types were showing a rapid decrease particularly with the under 30's age group, and this is mostly attributed to the digital age where an email, text or a WhatsApp (ask your children about that one) is sent instead of a card.

In the 'senior' age group there was also a similar decline in sales and this was put down to the cost of postage stamps. It was noted however that within that age group the number of people with laptops, tablets and iPhones had increased year on year. So for whatever reason we are still communicating but in different ways.



The results were quite amazing and this has now been extended to sending an Easter card as well. Sometimes we just assume that people will know when the services are and you may already be letting people know what's

# Making a difference in Ormesby St Margaret

"We have records showing the last time money was discussed in St Margaret's was back in 1983, so a review was well overdue!

"St Margaret's has had a proud record of paying its parish share in full, recently however with rising costs and little in the way of reserves we were starting to struggle financially.

"With the support of our incumbent, The Revd Mandy Bishop, we produced a booklet that simply set out the annual running costs, the expected income and the gap in between that we needed to fill. "A stewardship Sunday was held with a sermon on '10 points for Godly Giving' and a booklet, envelopes and an example standing order form was available for all church members. Five months later we are starting to see the fruits of our labours.

"Stewardship is not just about asking or even coercing people to give money. It is the way we respond to God's love and all that he gives us in giving of our time, our talents and our finances. We have seen more people coming forward to serve as Wardens, PCC members, sides persons, fundraisers etc - and yes the number of envelopes in the collection has increased along with additional standing orders.

"Stewardship is not a quick fix - a sticking plaster for a hole in the finances - it is about the way we as Christians respond to what we receive from God.

"Importantly as a parish we are now more open about the finances of our church; I can assure you that 'Stewardship Sunday' will be an annual event from now on."

A better understanding of the finances needed will often be the key to regular giving. *Geoff* 

# Gift Aid Small Donations Scheme

Personally I still like the enjoyment of opening the post on my birthday and other occasions! As part of your Christian mission how do you communicate with those who do not come to church? A parish magazine, newsletter, or a notice in the church porch? What works for one parish may well not work for another.

One parish I know decided many years ago that it would deliver a Christmas card to every house in the locality detailing the times of services along with a Christmas greeting and an assurance of a warm welcome if they attended church. It was not an easy task but one that they managed. going on, but if you are keen to try sending a card we are looking in future at producing in bulk such an item - this would be printed and personalised with your times of church services and contact details etc.

# - a reminder

The Gift Aid Small Donations Scheme (GASDS) allows parishes to claim a Gift-Aid style repayment to be received on small cash donations of £20 or less up to a threshold of £5,000 of donated income per year per church.

The scheme began on 6 April 2013. Archbishop's Council have issued some useful guidance which can be found at <u>www.</u> parishresources.org.uk/giftaid/ <u>smalldonations/</u>

This contains information about the scheme and what you need to do as well as some example Vestry

#### forms which can be used.

Alternatively, you can use your own records, as long as they separate out loose cash from that given in envelopes, and can exclude donations where you know than an individual gave more than  $\pounds 20$ .

All of the downloadable information sheets can also be printed and posted to you from Diocesan House.

#### Gift Aid in Practice 9: Small Donations Scheme (v3: 3<sup>eff</sup> April 2013)

The **diff Ald small Donations Scheme (GASDS)** allows a **Gift**-Ald style payment to be received on small cash donatons of £20 or less up to a threshold of £5,000 of donated income per year per Church. It should benefit parities by more than £15 and line a year. The scheme begins on April Edit 2013. #### Are we eligible to use the scheme

- Cs, or charities registered for Gift Aid with HMRC, are able to use the scheme if you have

The group is keen to encourage the ministry of open churches within the area of the diocese as places of exploration, contemplation and prayer, and can advise PCC's on best practice and risk management when opening their church to visitors.

The group works with a range of bodies including national, regional and local tourist agencies, Christian tourism and pilgrimage associations and networks, the Cathedral and other dioceses in the East of England.

One of the main areas the group has been working on recently is helping parishes mark the hundredth anniversary of the First World War, and throughout the centenary period up to 2018 the group will help to promote your parish events and highlight resources on the Open Churches section of the Diocesan website.

# Top tips in applying for a Heritage Lottery Fund grant

Are you thinking of applying for an HLF grant in the near future? If so, follow our top tips for success

1) Give yourself time. Applying for a grant can take up many hours and you need to devote sufficient time and energy to the task. Don't rush it!

2) If you know another parish which has already been successful in being awarded a grant, then ask them for help and advice. Perhaps they will look over your form for you. Most

importantly, share the work with someone else - don't shoulder the responsibility alone.

3) Before you even apply, register your interest with the HLF and obtain their advice. They are always happy to speak to parishes in the very early stages of developing a project and will be able to give you an indication of whether you are on the right track for success.

4) Don't apply for more funds than you need. The HLF will go through your application in great



detail and will scrutinize carefully what you propose to spend the money on.

5) Make sure that you include in your application how the project will benefit your local community. HLF sets great store by projects to benefit communities and you will need to demonstrate how you intend to fulfil this outcome by the completion of your project.

# Listed Places of Worship Grants VAT Reclaims for building work on churches

The Department of Culture, Media and Sports has appointed a new provider to administer the Listed Places of Worship Grant Scheme: Topmark (LPOW), 160 Bath Street, Glasgow, G2 4TB Tel: 0845 013 6601 Web: www.lpwscheme.org.uk

It is now also possible to download an electronic version of the application form, type your responses and then email the form directly to them, together with electronic copies or scans of the supporting documentation. You can also submit the form by email and the invoices separately by post if you are unable to send electronic copies or scans.

You can continue to request a paper version of the form from them and return by post.

# **Faculty Jurisdiction Rules**

It is often the simplest things that help to encourage people who visit the church to leave a donation to assist us in our work.

Many of you will I am certain use donation envelopes with the Gift Aid information on the front, always ensure these are easily accessible and there is a safe place where donations can be left.

If you have a visitor's book ensure that there are plenty of envelopes handy and a supply of pens really basic but often people do not have a pen with them.

It is a proven fact that approximately 1 in 8 signs the visitor's book - so the numbers coming into church are far higher

than we may think. This is an opportunity to politely request a donation for the upkeep of the building.

I have seen some really good examples of letters that can be printed and laminated to go near the book or in the porch; please call us if you would like some examples for your own church.

Sadly church wall boxes/safes can be a target for those who may be dishonest, do please check the security of your wall safe.

Police advise that a note to say that the box is emptied daily (not always practical I know) does help to deter theft.

# Grants for Places of Worship Programme

This HLF programme is for projects that involve urgent structural repairs to public places of worship or to fund work which encourages greater community use and engagement.

Under certain circumstances the HLF are able to fund utility work under the programme.

The works would be considered new capital work and should not be more than 15% of the overall project cost. Outcomes must demonstrate the work makes your church more useable for a wider community engagement.

# A helping hand

As Parish Funding Support Officer my role is to help parishes.

I can offer practical help through:

- Facilitating parishes seeking to embrace and encourage their stewardship of time, talents and money.
- Facilitating parish 'Vision Days' as a mechanism for helping parishes better discern God's way forward for them and as a means of releasing resources for growth.
- Preaching and teaching Christian Stewardship particularly in relation to giving.
- Presentations and talks on Christian Stewardship that offer interaction and discussion with opportunities for people to reflect upon this aspect of their discipleship.
- Training and on-going support for Benefice Stewardship Promoters.
- Help and advice in relation to the promotion of Gift Aid.
- I can also offer specific help for:
- Parishes wishing to engage in some form of capital fundraising project.
- Using initiatives such as Giving in Grace, Giving for Life, The Money Revolution,
- The Stewardship Toolkit for Rural Churches (see front page article), and/or helping a parish to develop an approach that fits specifically with their circumstances.
- Legacy advice for parishes wishing to encourage members of their church family to consider leaving a gift in their will to their church.

# Open Churches: are they secure?



Many PCCs are concerned that opening their church doors for visitors during daylight hours means leaving the building at risk. However, these fears can be overcome, provided that they have carried out the appropriate risk assessments and acted on the results. Indeed, keeping the church open can have very positive effects on security.

This is because attracting more people to visit the church and





encouraging greater interest from the community in general means that more 'eyes and ears' are present in the vicinity of the church to notice any untoward activity and deter theft and vandalism.

The presence of an increased number of people in and around the church gives the benefit of natural surveillance and outweighs the perceived risk generated by leaving the door

unlocked and open for visitors.

The secret is to find the right balance between accessibility and security. Opening the doors means that a church has taken seriously its responsibility to review its security arrangements by ensuring that the following points have been addressed:

- A full risk assessment has been carried out
- Local residents have been informed that the church is operating an open door policy so that they can observe activity
- Local people are encouraged to pop into the church when they are passing
- A rota of volunteer stewards is drawn up to be present in church whenever possible
- A secure storage area has been created in which valuables can be locked

Churches which have had a theft in the past can be particularly uneasy about opening their doors, especially if this is targeted theft of religious objects which occasionally happens, and which has happened recently in Essex and Suffolk where a number of items including a statute of the Virgin Mary and Jesus, and engraved wooden crucifix and bible stand and even a four foot wooden angel. But these are rare occurrences, and if reported quickly, churches can be alerted and extra precautions can be taken.

Those which still have concerns can talk the matter over with their insurance company or with Caroline Rawlings at the Diocese. There is no impact on the insurance premium in opening the church, and talking over any worries should put minds at ease.
