## 1. Introduction

- 1.1 The requirement for, and role, functions and constitution of, a diocesan Vacancy in See Committee is set out in the Vacancy in See Regulation 1993 (as amended). It only meets when the post of diocesan bishop is vacant.
- 1.2 A briefing paper prepared by the Church of England has been published, which sets out more detail and background, including procedures and membership requirements.

- 1.4 We suggest that members ensure that they have access to this paper and have due regard to it as and when the need arises for the Committee to meet and fulfil its purpose.
- 1.5 We recommend as an *aide memoire* that the executive officers of the Diocese maintain a record of the Committee's membership following each reconstitution (which occurs on 1 January of the year following the election of a new Diocesan Synod).

- 1.7 At the first meeting of the Bishop's Council held following the election of the Vacancy in See Committee, Bishop's Council should elect a Chair of the Committee from amongst their number.
- 1.8 At the same meeting, the Bishop's Council must appoint a Secretary to the Committee (usually the Diocesan Secretary or Diocesan Registrar – such a person is not permitted to be a member of the Committee).

## 2. Membership of the Vacancy in See Committee

- 2.1 The constitutional requirements are set out in section 1 of the Regulation as follows:

<b>(b) Elected</b>		
(vii)	At least 2 Clerks in Holy Orders beneficed or licensed under seal in the diocese, elected by the House of Clergy of Diocesan Synod	
(viii)	At least 2 communicant lay persons whose names are on an electoral roll of a parish in the diocese, elected by the House of Laity of Diocesan Synod	
(c)	No more than 4 nominated by Bishop's Council, being persons who reflect a special interest in the diocese or whose nomination is appropriate to secure a better reflection of the diocese as a whole	

2.2 There must be at least 21 members, with adequate representation of archdeaconries and parity between lay and clergy members insofar as is possible.

2.3 There is no power to co-opt additional members.
