Register your interest for the INEQE Safeguarding Survey Information Event

"Getting ready for the upcoming surveys"

The next stage of our audit preparations will be helping parishes engage with the surveys that INEQE will be putting online in September.



These surveys will give **everyone** the opportunity to share their views confidentially with INEQE, and is an important part of our learning.

We recognise that many parishes will have a number of queries in relation to the surveys and how best to engage people within their community to participate in them.

Therefore, to best support Parish Safeguarding Officers and their wider parish community, we will be hosting a couple of information events. These sessions are designed to provide;

- An overview of the survey process,
- An explanation of what to expect,
- An opportunity to discuss any potential challenges that may affect participation.

The information events are open to all. Therefore, please share this news with your wider parish team who may be interested in knowing more about this. The sessions will help attendees better understand the survey requirements and consider how they may wish to organise themselves in advance. This includes discussing **accessibility requirements**, **identifying appropriate stakeholders** to be involved in survey completion, and exploring any **practical considerations** that may support effective engagement with the survey process.

When are the sessions?

The Project Team will be hosting **two** sessions **via Zoom**, the times are as follows;

Morning session: Thursday 20th August 2026 - 10am - 11.30am

Evening session: Tuesday 1st September 2026 - 6pm - 7.30pm

You only need to attend **ONE** session.

We will send further information to you so that you can catch up on the information shared at a convenient time for yourself.
